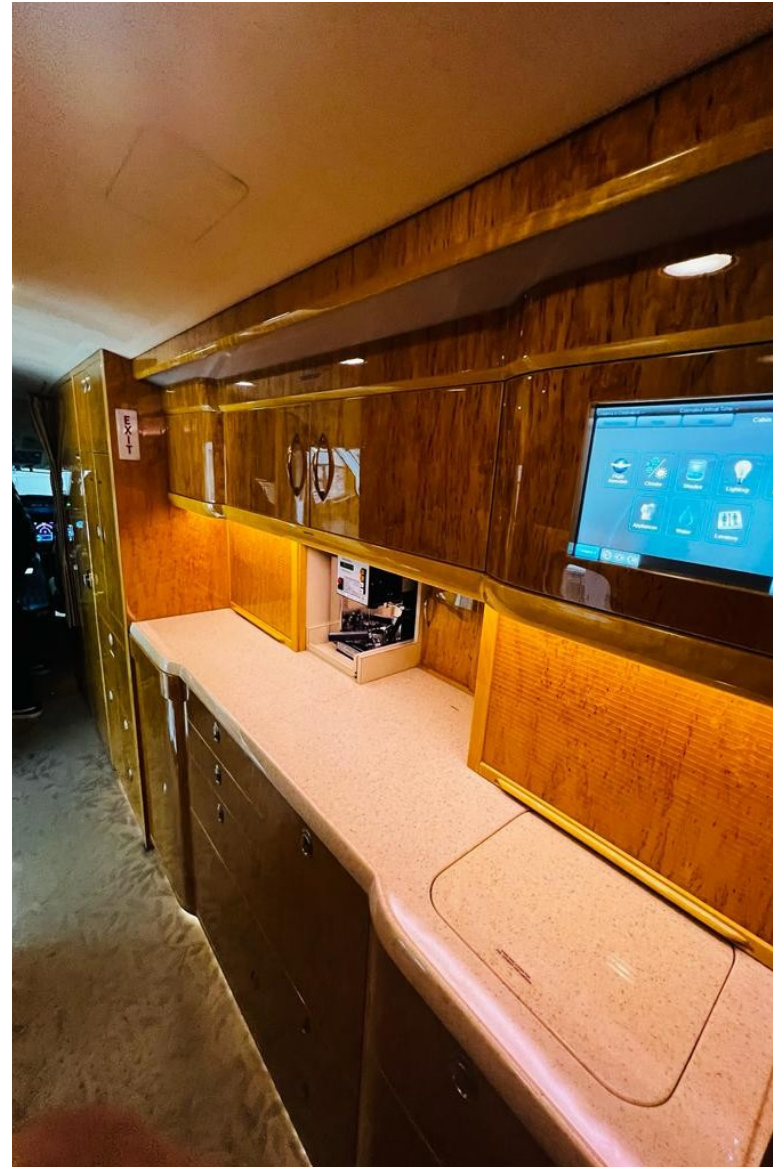
CABIN LAYOUT
